



Exhibitor Terms & Conditions (NI)

All bookings are subject to availability and the organisers reserve the right to decline any booking if deemed unsuitable or of detriment to the good reputation of the event. Stand space is licensed to the exhibitor on a non exclusive basis. Sub letting or stand sharing is not permitted without prioragreement from the organiser.

Booking Policy

Bookings are accepted on a first come, first served basis and secured when an application is accompanied by full payment. Spaces maybe limited in each sector and the rates paid may vary between individual exhibitors based on optional extras

Consideration is given to create a well balanced and interesting exhibition. When the event is fully booked, the organiser operates a waiting list.

Fees, Payment & Cancellations

The exhibitor agrees to pre-pay all fees for stand space with this application. If an exhibitor wishes to

cancel, then he/she must do so in writing. If the written cancellation is received eight weeks or more before the show date, a 10% cancellation fee will apply.

The organiser reserves the right to retain in full the agreed exhibition fees if the cancellation is received in writing eight weeks or less before the show.

Insurance

Exhibitors are responsible for their own insurance cover for; Public Liability, Employers Liability, Personal Injury, Theft and Damage (damage caused by the exhibitor or damage incurred by the exhibitor). The organisers cannot be held responsible for any losses howsoever arising.

Arrival & Set Up

Exhibitors will be given at least two hours before the public opening to set up. In the event of problems or late arrival, the organiser should be contacted via mobile telephone.

Vehicles for loading and unloading must be parked where designated by the organiser and must not breach fire or access regulations. No goods shall be placed on the floor so as to obstruct the free passage or viewing of goods by persons using the events, nor should displays unreasonably obstruct the line of sight to immediately adjacent exhibitors' displays.

The fixing of signs to the shell schemes shall be done so in accordance with the supplier of the shell scheme units.

Compliance with the venues' rule and regulations is expected at all times. Advertising or soliciting other exhibitors for other events is not permitted. Exhibitors must attend the show until the advertised public closing time.

Sales & Conduct

Exhibitors are expected to comply with all aspects of the food hygiene legislation, sale of goods legislations as well as any relevant acts of parliament relating to your product. Exhibitor products must comply with Environmental Health, Trading Standards and other statutory/industry bodies.

The organiser will take reasonable steps to ensure the exhibitor is aware that compliance to current legal requirements is a pre condition of exhibiting and those exhibitors that contravene any relevant trading laws are

not permitted to trade at the shows staged by the organiser.

Exhibitors must comply with Trading standards enforcement officers or similar public bodies should they attend or intervene on behalf of a customer.

All items displayed for sale must be price marked and receipts issued. Information regarding the exhibitors trading name, registered office and contact details must be readily available for visitors to inspect.

Publicity & Visitors

The organiser shall promote the event in a way it sees fit in order to maximise awareness and attendance of the shows. The organiser makes no guarantees as to which formats or publications will be used to market the show, nor makes any guarantees on the attendance figures.

Postponement or Cancellation by the Company

The organisers may postpone or cancel the show for any reason by giving exhibitors four weeks notice before the exhibition opening date.

The organisers' liability for choosing to cancel the show will be limited to the fees paid in respect of the show to the organiser and no additional or incurred costs will be due.

The exhibitor exhibits and chooses to exhibit at its own risk and the organiser accepts no liability for losses, damages or incurred costs however so arising suffered by the exhibitor.

Equipment Hire

The exhibitor is responsible for the condition of equipment and shell scheme it has hired and must adhere to any reasonable instructions given by those bodies who have supplied the equipment. For the avoidance of doubt, Exhibitors are solely responsible for the return of any equipment in the same good condition in which it was received.
